

Privacy policy and protection of personal information

This Privacy Policy and protection of personal information sets forth the practices of RED ALL BELGIUM (hereinafter: "RAB") for the collection, use or disclosure of personal information under the operation of its website and your membership as a affiliated member of RAB (hereinafter: "the customer")

A Personal information

RAB. collects manually personal information in the course of its relationship with a shop and customer of the concerned shop:

Reserved access - Access to the present website is exclusively reserved to the beneficiaries of a franchise of excise and an exemption from VAT. as organized by :
;- article 42, § 3.1 and 3.2 of the Code of value-added tax of 3 July 1969.

The personal information that we may collect manually and keep in these situations include:

- Your name
- Your account;
- Your postal address;
- Various information about your purchases.

In general, RAB. uses your personal information to:

- Process and fulfill your sending of a document from a shop;
- Inform you of modifications to our conditions and our policies and/or for other administrative purposes;
- Protect the security and integrity of our Website, our organization and our affiliate members .

B Disclosure to Third Parties

Unless we specifically ask you and you authorize us, it is RAB. policy not to sell or transfer to third parties any personal information about your documents.

Internally, RAB. allows limited access to your personal information and only to persons who need to know for the purposes of their duties.

It may happen that RAB. makes use of your personal information and may be accessed by the shops. In this case, confidentiality measures are taken between RAB. and those shops so that your personal information be used in a manner consistent with this Policy and applicable law, rule or regulation.

RAB. reserves the right to disclose your personal information if required by law or if court orders are issued including sending of a subpoena or a search warrant. RAB. reserves the right to disclose any information it considers necessary in good faith: a) to comply with any legal requirements or judicial proceedings, b) to enforce the Terms of use Agreement of RAB.'s Website or c) to protect the rights of its customers and shops.

At last, in the case of a corporate reorganization, merger, transfer or other disposition of all or part of the assets of RAB. (including the proceedings of bankruptcy or insolvency), personal information about Members and other data collected as described in this Privacy Policy and protection of personal information are part of the transferred assets and may be shared with the other parties to the transaction.

C Use of cookies

RAB. does not use any kind of cookie technology (cookies) for the rapid identification and management of your details

D Storage

The RAB site is operated and hosted on the servers of TELENET and Microsoft AZURE platform.. IF YOU ARE A VISITOR FROM ABROAD AND YOU PROVIDE PERSONAL INFORMATION ABOUT YOU, YOU AGREE THAT YOUR PERSONAL INFORMATION BE TRANSFERRED AND PROTECTED BY THE APPLICABLE LAW OF MICROSOFT AND TELENET.

E Security and storage

RAB. takes reasonable technical means to ensure a safe environment and protecting the privacy of its customers such as: secure cloud, firewalls, use of antivirus, access management, intrusion detection.

F Retention

At your request or upon termination of your subscription due to an undesirable behavior, we will close your account and delete your personal information.

Despite the closure of your account, RAB. reserves the right to hold, for a reasonable period, certain personal information about you to be in compliance with the law, prevent fraud, collect fees owed, resolve complaints, cooperate with an investigation and any other act permitted by law. Upon expiry of this period, the residual data files will be destroyed or deleted from RAB.'s system.
